## Release and Indemnification Agreement

### Read Carefully before signing

I hereby acknowledge that participation in the cheerleading program carries with it potential risks and Hazards. My child could receive secluding But not limited to; stunting, tumbling, gymnastics, dance and aerobatics being practiced or performed as Part of the cheerleading program and events.

I understand that the coach(es)from Xtreme Outlaws may not be present, may not be physically close Enough to any given participant at any given time, or may not, for any other reason, be able to prevent An accident from occurring.

I hereby attest and verify that my child is physically fit to participate in the strenuous exercise that is part Of the cheerleading program.

IN CONSIDERATION for my child having the opportunity to participate on any cheerleading team Coached by the Xtreme Outlaws, I hereby release the coaches, assistant coaches, volunteers, helpers, Practice and/or competition facility owners, employees, and/or volunteers, or any one or more of them, or Their executor, administrators, heirs, next of kin, successors or assigns from liability, resulting from injury Or death as a result of my child's participation in cheerleading activities and serious or minor injuries as a result of some of the activities in related events

IN FURTHER CONSIDERATION of acceptance of my child in the cheerleading program:

- a) I hereby agree to comply with the rules and regulations applicable to the cheerleading program, to encourage my child to comply, and to assist the cheerleading coaches(es) and the assistants and/or volunteers in encouraging all participants in the cheerleading program to comply.
- b) by myself, my executors, administrators, heirs, next of kin, and assigns.
- c) I HEREBY WAIVE AND RELEASE any and all claims that I may have against the cheerleading Coaches (Xtreme and anyone they see fit to assist them), the practice or event facility owners, empolyees, and/or volunteers, or any one or afore mentioned executors, administrators, heirs next of kin, successors or assigns (the release's) from any liability, including any and all claims for damage caused or by any of them resulting from or arising out or my child's participation in cheerleading activities and related events.
- d) I FURTHER HEREBY AGREE TO INDEMINITY AND HOLD HARMLESS the releases and each of them against any such claim for injury, damage or costs, including attorney fees, arising from related or otherwise occurring as a result of the negligence of any of them in connection with by child's participation in cheerleading activities and related events AND
- e) I FURTHER HEREBY CONSENT to allowing my child to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness resulting from or arising out of my child's participation in cheerleading activities and related events.
